Cottage Break-Ins

When and Where

Mid-October saw a rash of cottage break-ins along <u>Vikings Point Lane</u>, and <u>South Mazinaw Heights Road</u>. The police are involved, and neighbours are assisting each other by keeping an eye on adjacent properties, sharing information on the MPOA Facebook Group, and by reporting any suspicious activities to the police.

The primary motive appears to be a vagrant finding a place to stay, rather than theft. Food has been consumed, and washroom facilities used. When closing the cottage this year, consider the possibility of a break-in and how you would protect your property. (Cameras, neighbours, periodic visits). Tip: you can log on and look at your Hydro One energy usage; a sudden spike after you've closed up is a possible sign of someone taking up residence. (Thanks to Derek Panchyshyn for this idea).

Lake Health

Phosphorus Levels

From the Mississippi Valley Conservation Authority's communication of May 10th 2022:

"Results from the MVCAs lake sampling program show that the lake is maintaining its oligotrophic status with deep secchi depths indicating good water clarity, and low to moderate concentrations of total dissolved phosphorus. Dissolved oxygen levels at depth within the lake continue to be ideal for Lake Trout" Good news for trout fishermen. HOWEVER: the lower lake has had phosphorus readings trending upwards (bad!) for the last 6 years, and even the upper lake had a slightly high reading. What contributes to high phosphorus? Fertilizer run-off, and malfunctioning (or inadequate) septic beds. If you have any doubt that your septic is up to the task, please have it inspected.

Eurasian Milfoil

Invasive Species Confirmed - Unfortunately, the Mississippi Valley Conservation Authority has confirmed that Mazinaw has the invasive weed called "Eurasian milfoil". The MPOA is working with the Conservation Authority, Watershed Canada, the Parks Manager and politicians to address and generate an action plan for MPOA members. Unfortunately, once an invasive species is in a lake it is very hard to manage; however info on targeted control methods used on Malcolm Lake is available here https://malla.ca/eurasion-milfoil For more info on Milfoil ID see: https://www.invadingspecies.com/invaders/aquatic-plants/eurasian-water-milfoil/.

When boating, please try to avoid traversing the weed patch as this can help spread it.

If you see any patches out of the norm, or any green algae please report to <u>mazlakesteward@gmail.com</u> and <u>communications@lakemazinaw.ca</u> with photos and coordinates. Also, please be reminded that heavily landscaped lots stripped of the "ribbon of life" can exacerbate phosphorus levels in our lake which increases water weeds. Avoid fertilizers especially with a "P" compound and consider the FREE shoreline restoration program detailed in our May newsletter, see details at: <u>https://naturaledge.watersheds.ca</u>

iSample Program

Lake Sampling- This summer, our lake volunteers collected samples pursuant to the Federation of Ontario Cottager's ISample 2.0 Program aimed at identifying various invasive species. The lab results should be available late Fall or early Winter and we will share the results upon receipt.

Shoreline Planting Project

Shoreland Planning Resources released- The FOCA steering committee of the *Planning for our Shorelands* project has released 2 new resources designed to help facilitate more resilient and healthy waterfront communities: 1) Environmental Net Gain; and 2) Shoreline Naturalization Planting Plantemplate. Flood Risk

Adapting to Rising Flood Risk- A report by Canada's Task Force on Flood Insurance and Relocation was recently released stating that the total residential flood risk in Canada is now estimated at **\$2.9B per year**. The majority of risk (89%) is concentrated in a small number of the highest risk homes (10%). Additionally, the report notes that 9 in 10 Canadians living in high-risk areas remain unaware of their flood risk. <u>Access the digital report on this webpage.</u>
